Submit your claims online

All regular full-time and permanent part-time employees are insured under **Basic Group Life**, including an indemnity for **AD&D**, equal to one times the current annual salary.

If you chose to carry **Supplementary Life**, it also includes an **AD&D** indemnity, equal to one or two times the current annual salary.

If you chose to enroll in the **Voluntary Accidental Death & Dismemberment** plan, you are eligible to include coverage for your immediate family members under the Family Plan. You can add this coverage at any time in \$10,000 increments to a maximum of \$300,000.

As a result of positive claims experience, in **September 2013** the payroll deductions and Employer contributions for the **Group Life Insurance Accidental Death & Dismemberment** coverage will decrease, as illustrated below:

eClaims is the newest way for you to submit your claims. If you can take a digital photo, you can submit your claims through the secure member site.



#### The new eClaims system is easy to use

eClaims is simple to use – just complete a few questions, attach a photo or scan of your receipt and submit. Visit medavie.bluecross.ca – select 'plan members' in the upper right-hand corner and log in to the secure member site. Click on the 'e Claims' tab and follow the instructions.



#### Sign up for direct deposit

To get started using eClaims, you'll need to sign up for direct deposit - to have your reimbursements deposited directly into your bank account. You can register for direct deposit at any time through the member site.



#### Options for submitting claims

eClaims joins our other options to submit your claims: having your provider submit electronically for you with no out-of-pocket expenses beyond your co-pay, through the mail or by visiting one of our Quick Pay locations.
