

FORM SD1 - Statutory Declaration with Proof of Marriage



This statutory declaration **must** be completed when a plan member is required to provide proof of marriage but does not possess a marriage certificate issued by the Registrar General of Vital Statistics at Service New Brunswick (with a registration number and date of registration) or one issued by a similar issuing body in another province or jurisdiction, a Service New Brunswick Form 10 – “Statement of Marriage” or a Service New Brunswick “Certificate of Marriage”.

This statutory declaration alone is **not** a substitute for proof of marriage. Supporting documentation (e.g., Record of Solemnization of Marriage; Church-issued document) **must** still be submitted with this form. Vestcor will review all such documents and may seek additional information or documentation at its discretion.
