

Teachers' NBTPP BOARD BIOGRAPHIES

Larry Jamieson (Chair)

Larry Jamieson is the Executive Director of the New Brunswick Teachers' Association. He taught and worked in middle schools and high schools for 21 years; the last 12 of these as Principal of Harvey High School. He joined the association in 2001 and served in several staff positions. During this time, he provided pension advice to teachers, participated in several rounds of collective bargaining and served during a major pension reform. Larry has experience on a number of local, provincial and national boards. He has a Bachelor of Education, a diploma in undergraduate studies (counselling), and a master's degree in education administration from the University of New Brunswick.

Jennifer Morrison, CPA, CA (Vice-Chair)

Jennifer Morrison is a Chartered Professional Accountant with more than 25 years of experience in the pension and trust fields. She is currently the Treasurer at the University of New Brunswick. Prior to joining the University, she held the role of Director of Trust Fund Administration with the Treasury Division of the Department of Finance. Jennifer has been on the NBTPP Board since 2014 and is the Chair of the Audit Committee. She is also a trustee for the Shared Risk Plan for Academic Employees of the University of New Brunswick.

She has a Bachelor of Science degree (Economics) from Mount Allison University, and obtained a Chartered Accountant designation through the New Brunswick Institute of Chartered Accountants.

Paul Martin, FCPA, FCA (Trustee)

Paul Martin is the Comptroller for the Province of New Brunswick with oversight of accounting, internal audit, enterprise risk management, financial systems and consulting. He has 38 years' experience in public practice as a former partner with a National accounting firm and currently with the provincial government. He currently serves as a member of the Chartered Professional Accountants of Canada's Public Sector Accounting Discussion Group and the Employment Benefits Task Force. Paul is a member of the Audit Committee for the NBTPP Board, and is also a trustee of the New Brunswick Public Service Pension Plan.

Reno Thériault (Trustee)

Reno Thériault is a retired educator living in Grand-Barachois. He worked in education for 18 years, first as a Teacher, then as Vice-principal and Principal at Polyvalente A.-J.-Savoie in Saint-Quentin. He was President of the Association des enseignantes et des enseignants francophones du Nouveau-Brunswick (AEFNB) from 1987 to 1989 and then served the Association as a Professional Development Officer and Executive Director (and Pension Advisor) until retirement in 2005. From 2006 to 2016, he served on the Board of Directors of the New Brunswick Investment Management Corporation (NBIMC) and, from 2012 to 2016, was Chair of NBIMC's Human Resources and Compensation Committee and was also a member of the Governance Committee. Reno is the Chair of the Governance Committee for the NBTPP Board. Since 2016, he is also a member of the Board of Directors of Vestcor Corp.
