

# Teachers' NBTPP BOARD BIOGRAPHIES

## Larry Jamieson (Chair)

---

Larry Jamieson is the retired Executive Director of the New Brunswick Teachers' Association. He taught and worked in middle schools and high schools for 21 years; the last 12 of these as Principal of Harvey High School. He joined the association in 2001 and served in several staff positions. During this time, he provided pension advice to teachers, participated in several rounds of collective bargaining and served during a major pension reform. Larry has experience on a number of local, provincial and national boards.

He has a Bachelor of Education, a diploma in undergraduate studies (counselling), and a master's degree in education administration from the University of New Brunswick.
